#### **Breakfast Club**

Shania S brought the idea of a school Breakfast Club supplying a free breakfast to any student to the P&C and school in 2023, and then she and Ana T worked with the school to deliver it in Term 4 of 2023.

In 2024 the P&C and school sought external funding and a larger base of volunteers to make the program more sustainable. In May 2024 the P&C was able to secure a \$1,000 grant for the Breakfast Club from Club Rivers. With the support of parent volunteers and the Narwee PS Principal and staff, we were able to re-start Breakfast Club on Monday 20 May. It has continued to run at 830am every Monday except a few days when there have been other school events. School SLSOs also play games with students after they have eaten.

Ana T has been coordinating the purchasing of supplies each week and the program has been delivered by a team of volunteers: Kelly, Marie, Rebecca, and Maryam. Many thanks to everyone involved in delivering and supporting this important program.

More volunteers are always welcome. We believe that Club Rivers will continue to fund the program going forwards, and will be applying for further funding at the end of this term.
